Aims of the new councillors

Three of the eight new Unofficial Members of the Legislative Council yesterexpressed strong day personal views of how they would represent the public on a wide range of subjects.

The three, a trade unionist, Mr Leung Tak-shing; an engineer, Mr S.L. Chen, and a community leader, Mr Wong Lam, made frank remarks to reporters barely an hour after the official announcement of the expanded Legislative Council appointments was released.

Their comments covered workers' welfare, youth workers' welfare, youth problems and public expen-

Taking the lead in the joint interview, Mr Leung firmly disagreed there would be difficulties in his work as a Legislative Councillor because of his past ties with the rightwing Trades Union Congress.

Mr Leung said he was never politically inclined in his TUC relationship. All he interested in was the welfare of workers and the work toward achieving this aim.

The councillor said as a matter of interest he was no longer holding office in the TUC. Formerly, he was an overseas relations man for the organisation.

Back to his favourite topic on workers' welfare, Mr Leung pointedly stated that a lot could still be done for workers in Hongkong particularly in getting more fringe benefits for

them.
His colleague, Mr S.L. Chen, said he saw his appointments as the Government's recognition of the contribution that technocrats can make to Hongkong.

Mr Chen pledged he would use his expertise to help evaluate the many projects proposed for the development

of Hongkong.

Mr Chen, as the general manager of a public utility company, was asked whether public utilities should be managed by the Government instead of leaving it in the hands of private enterprise, and also his views of private also his views of private enterprise's share of the profits.

In reply, Mr Chen said he felt public utilities, as in Hongkong today, should definitely have a

share of "reasonable profits."

Reasonable, he explained, would be gauged in terms of what normally commerciallyoriented private enterprises expect of its investment in the country concerned.

Mr Wong Lam pointed out that he was but a "salaried worker" and linked with work

in the field of public transport. His interest, said Mr Wong, would definitely be directed on transport in Hongkong and also on youth activities.
